## **MINUTES OF May 7, 2015 MEETING**

- 1. The monthly TMC meeting was called to order by Co-Chairman Hayden. All member organization representatives were present except: AMVETs, AAA, VFW, and WWP

  - c. Presentations: none
  - d. Minutes approved for April 2, 2015 meeting.
  - e. The Treasurer's report approved.
- 2. Co-Chair Discussion Items: Co-Chair Hayden (MOAA) thanked IAVA and ROA for their work in setting up a meeting with TMC and VA Secretary Bob McDonald. The meeting will be May 15 at 2 PM at ROA. The HASC mark of the defense bill blocked many of the White House recommendations on personnel costs, but moves forward with retirement reform. The Senate expects to complete its mark of the defense bull by the end of next week. The SASC-P marks on May 12.

Co-Chair Brown (AFSA) provided details on the budget resolution. Thanks to AFA for highlighting the TMC in their magazine.

Co-Chair Hayden discussed a contentious House amendment awarding the Purple Heart to victims of the Oklahoma City bombing. TMC declines taking a position, but individual organizations are welcome to take positions.

- 4. Committee Co-Chairs briefed on key issues since the last TMC meeting. Highlights are noted below.
- **a. Awards**. Co-Chair Huck (NMFA) asked associations to submit nominees. No nominations have been received yet.
- b. **Guard and Reserve**. Co-Chair Madison (TREA) discussed recent vets status legislation that has been introduced. There is no update on a Guard and Reserve Caucus breakfast.

Co-Chair McElligott (COAUSPHS) met with Sen. Whitehouse (D-R.I.) regarding S. 602, S. 743, and S. 1152.

The next committee meeting will be May 14 at 10:00 AM at TREA.

- c. **MilCon/MWR.** No report.
- d. **MilPersonnel/Compensation/Commissaries.** Mike Hayden (MOAA) announced that the HASC mark is silent on the active duty pay raise. The mark did not cut commissary funding or housing allowances. He provided an update on the White House response to MCRMC proposals and noted that DoD rejects the commission's TRICARE changes.

Brooke Goldberg (NMFA) said that opposition to keeping BAH rates and commissary funding as-is will be in the SASC.

e. **Retired Affairs.** Co-Chair Barron (MOAA) provided information on an amendment by Rep. Chris Gibson (R-N.Y.) that delayed implementation of retirement changes. The amendment was defeated in committee.

The next committee meeting will be May 19 at 9:00 AM at FRA.

f. **Survivor Benefits**. Phil Odom (MOAA) announced a Senate companion bill eliminating the SBP-DIC offset. A TMC letter of support is being worked.

Rick Jones (NAUS) discussed recent legislation by Duckworth (D-III.) and Rigell (R-VA.) about Fry Scholarships.

The next committee meeting will be May 22 at 10:00 AM at TREA.

- g. **Taxes, Social Security.** Co-Chair Odom (MOAA) said tax measures may move in Congress this summer.
- h. **Veterans.** Co-Chair Brown (AFSA) invited TMC organization to meet with VA Secretary Bob McDonald at ROA.

Co-Chair Norton (MOAA) invited interested parties to attend a meeting with Census Bureau

about their American Community Survey, a tool used to measure local veterans' populations. The meeting will be May 15 at 10:00 AM at MOAA.

i. **Health Care**. Co-Chair Washington (FRA) announced that DoD rejected the MCRMC health care proposals.

The next committee meeting will be May 28 at 8:30 AM at FRA.
